The beautiful Albuquerque weather allows our residents and the residents of our neighboring communities to be outside almost all year long, walking, running, bicycling just to name a few. Trees, bushes and shrubs interfere with the ability to maneuver the sidewalks in our beautiful neighborhood. A height of 7 feet from the sidewalk and a few inches in from the sidewalk allows for people to walk side by side without dodging branches or getting caught on thorny bushes.

For all of 2018: 1091 pounds of aluminum was collected for a total of \$545.26.

For the first three months of 2019, we took in 297 pounds of aluminum, for a total of \$147.10.

Please save your recyclable aluminum for HEAR's monthly recycling collection every first Saturday of the month from 8:30-11:00 a.m. at Rotary Park (7725 Quintana Dr.). All proceeds benefit HEAR. You can just place you aluminum in the bed of the truck ... sometimes Susan is even there to to give you a big cheerful Thank You. If you can't make it to the park, call Susan Tackman, HEAR Recycling Chair at 822-8761 to arrange an alternative way to donate your aluminum.

NOTE: while it can still be recycled, **aluminum foil must be separated from the aluminum cans**. Thanks for your help with separating the foil and cans prior to bringing them to the park.

Treasurer's Report



We closed 2018 out with \$17,432 in our accounts. Memberships were 396 (Thank you). We took in \$10,140 from Memberships and had expenses of \$3772. The expenses were primarily for newsletters, neighborhood beautification. But additional items such as the new Heritage East Flag for Rotary Park, Thank you/gift cards and refreshments for the combined National Night Out with Heritage East and Quintescence Neighborhoods and Website costs. Our Neighborhood cleanup crew began college this fall and are no longer working for HEAR. I am glad to announce that Bill Spahn and has agreed to take on the Treasurer responsibilities for HEAR. Bill has been in Heritage East for more than 25 years. Welcome to the Board. To date we have 13 2019 members, and \$18,166.39 in the HEAR accounts. Slow Down Albuquerque – Freedom Way

Due to numerous complaints about speeding on Freedom Way and the safety of our children, pedestrians, bicyclists and neighbors. A request was submitted to the City of Albuquerque Neighborhood Traffic Management Program (NMTP) to evaluate for traffic calming measures. The City staff in Traffic Engineering Division will collect and evaluate traffic data and identify needs. The criteria used to determine a need for traffic calming measures include:

- Crashes that might be corrected if traffic calming is built
- An 85th percentile speed (in either direction) of at least 30 miles per hour. 85th percentile is the speed that 15% of traffic exceeds. For example if a street has 1000 vehicles traveling on it per day and an 85th percentile of 30 miles per hour, it means that 150 of those vechiles are traveling faster than 30 mph.
- Peak hour directional volume of 400 vehicles. This means that during the busiest traffic hour of the day, one direction of movement has at least 400 vehicles, which would be unusual for a typical residential road.
- Cut-through traffic of 25% or more during peak traffic hour. If at least 25% of the traffic passes from one end of the study area to the other without stopping, then the road meets this criteria.

A road or street must meet two of the above criteria to qualify for traffic calming. If fewer than two are met, we will get a letter telling us that Freedom Way road doesn't qualify for traffic calming.

If the evaluation determines action should be taken, the neighbors on Freedom must become involved to determine acceptability of measures and 2/3 of the effected households will have to sign the petition to allow for any implementation of calming measures. Priorities and budgets also play a part in any actions. Update on the September 7 Garage Door Damage Incident

Overnight on September 7 nearly two dozen homes in our area experienced damage to their garage doors or landscaping (allegedly) by an adult and two juveniles driving a stolen truck (ABQ Journal Article https://www.abqjournal.com/1218121/policearrest-2-after-stolen-truck-crashes-intohomes-in-ne-albuquerque.html). All three were arrested and the court cases continue to work their way through the legal system. Here is an update on the state of the cases as of early January when a meeting was held at the DA's office with victims of the crime.

The case is being handled by Evan Cochnar (office - 222-1189) & Joey Montoya (Cell - 505 389-6473) as the prosecutors handling the case against the charged adult. ADA Alicia Papone is prosecuting the juveniles.

One of the juveniles has pled guilty and was placed on probation. The second juvenile has been held in detention since his 9-7-18 arrest (as of 1/3/19). He has had issues with law enforcement prior to the September 7, 2018 incident and the Juvenile Judge agreed to keep him detained. He is scheduled for trial in April 2019.

The adult was released on pre-trial release at the lowest level supervision by a District Court Judge even though the prosecutors filed a "Preventative Detention" Motion to the Judge. She felt his criminal history did not merit detention. He has been indicted on 57 felony counts. The Grand Jury was sufficiently outraged by his action that they requested that the DA's Office add the conspiracy charges. His trial has been scheduled for November 2019.

The 26 victims are mandated by the State Law to be interview by the Defense lawyers and are to be subpoenaed for these meetings in the near future. If the witness/victims do not show up for the meeting with the defense, the charged criminal count must be dismissed. Out of the 26 victims who were mailed invitation letters only four (4) showed up for the 1/3 meeting. The DA's urged all the victims to show up in force to impress the Judge so he does not give any slack to the defendant at sentencing. The prosecution is seeking prison time. A Plea Agreement is pending.
