# **RV** parking in Heritage East

RV parking in Heritage East has grown substantially during the past 10 years. The Heritage East Covenants prohibit the parking or storage of any RV on the property and the City of Albuquerque prohibits the parking of any RV on the street. The City of Albuquerque Integrated Development Ordinance (IDO)

section 4-3(F)(16) Parking of Recreational Vehicle, Boat and/ or Recreational Trailer provides a clear description of RV parking requirements, which I have abbreviated below. The full IDO can be found on the City's web site and the relevant section searched for in the interactive ordinance interface.

The RV must be parked either (1) inside an enclosure, (2) outside in a side or rear yard, or (3) outside in a front yard with the unit perpendicular to the front curb and the body of the vehicle at least 11 feet from the curb and not extending over any part of a sidewalk. Please abide by these requirements and be cognizant of your neighbors.

# Registering your security cameras

The City of Albuquerque and the Bernalillo County District Attorney's Office, in conjunction with the Albuquerque Police Department and the Bernalillo County Sheriff's Department, are partnering to create the county's first-ever security camera map. These agencies are encouraging business owners and residents to provide information about their security cameras to assist officers and prosecutors with the investigation and prosecution of crime in Bernalillo County.

By participating in this program, you will help law enforcement agencies more quickly identify where video evidence might exist when investigating crimes in your area.

Registration is easy and no one has access to your cameras. If a department needs assistance with a crime in our area and your camera is identified, they contact with you to request access to recorded footage. # Weed, litter and snow removal ordinance

Weeds have been a constant problem in Heritage East and throughout Albuquerque. Weeds are particularly vexing right after the spring rains, but can be an issue any time of the year if they are not managed. To



encourange compliance with the city ordinance on weeds, a number of letters have been sent out to households from HEAR and some reported through 311. When our properties are maintained, the entire neighborhood looks beautiful and our property values remain high. We all win.

Excerpts below describing the ordinance are taken directly from the cabq.gov website (<a href="https://www.cabq.gov/planning/code-enforcement-zoning/nuisance-weed-removal">https://www.cabq.gov/planning/code-enforcement-zoning/nuisance-weed-removal</a>):

The Weed, Litter and Snow Removal Ordinance (§ 9-8-1) is intended to promote general health, safety and welfare for Albuquerque by prohibiting the maintenance or accumulation of plants determined to be of major allergenic significance, those which constitute a fire hazard when wind collected, or those which otherwise present a hazard or nuisance to inhabitants of the city. Further, the ordinance is intended to promote the growth of native and other grasses/plants whose root structures tend to aid in stabilizing the soil and reducing dust.

Because this ordinance is law with enforcement that can include court appearances, fines and even jail time, it's vital that you do not ignore any notices of violation that you may receive. If you do receive a violation notice and need more time to tend to the violation or there are circumstances you need to discuss, please call the Code Enforcement Inspector listed at the bottom of the notice. The inspector needs to speak with you in order to make accommodations for your request. If you feel you have received a violation notice in error, please call and the situation can be discussed with the inspector.

The rules of the city ordinance:

- Remove any weeds with a height or width of more than 4 inches from the following areas:
  - The front, rear or side yard of your property
  - From the property line all the way to the curb, including the sidewalk. If you don't have a curb adjacent to your property, then the area 10ft outside of your property line
  - From your property line to the middle of the alley adjacent to your property
- The following plants are considered "weeds" per the ordinance: Pigweed, Russian Thistle, Ragweed, Lamsquarter, Kochia, London Rocket, Flix weed, Tansy Mustard, Spurge, Silverleaf Nightshade, Field Bind Weed, Purslane, Hoary Cress, yellow Foxtail and Green Foxtail (pictures available at cabq.gov).

# Treasurer's Report



During calendar year 2020 we received 356 paid memberships (Thank You) totaling \$9,068.08, donations of \$485.20. and \$864.87 from recycling. After spending \$12,694.30

on Heritage East beautification projects, wall repair and the like, \$2,548.68 on newsletters and \$1,096.47 on miscellaneous items to support HEAR, such as the website, the P.O. Box and volunteer recognition, we ended the year with \$13,324.14 in our bank accounts.

So far this calendar year, we've added \$4,240.72 from 171 paid memberships (again, Thank You) and spent \$641.52 on newsletters and \$185.01 on welcome bags, which brings our bank account total to \$16,266.75. We haven't had any big projects yet this year, mainly due to the weather and COVID. If you're a person that has ideas on how to efficiently spend our funds to improve our neighborhood, the best way to be heard is to join the HEAR board. It's pretty easy to join and, at least for the foreseeable future, the meetings are virtual.

We at HEAR understand how hard the last year has been both emotionally and financially and greatly appreciate all the support we've received. Here's hoping for better things to come our way soon.

# Recycling update



HEAR Aluminum recycling occurs the first Saturday every month from 8:30 am until 11:00 am in the parking lot of Rotary Park in Heritage East. A HEAR Recycling magnetic sign is affixed to the pick-up truck collecting

the aluminum. All aluminum is eligible for recycling, but aluminum cans should be bagged separately from any other aluminum, such as foil, roasting pans, and pie plates. Pet food cans that do not have white lining are generally not aluminum. As a rule of thumb, if a magnet sticks to a can, it is NOT aluminum.

During the past 14 months, HEAR has collected over 1500 pounds of aluminum for recycling. Although the current rates for recycled aluminum are very low, the recycling efforts have still added over \$432 to our account. We should also take delight that we have kept 3/4 of a ton of aluminum out of our landfill. We can all do our part to keep Albuquerque beautiful.

# Heritage Hills Park Gatekeepers Needed

Since April 2018, a group of neighbors have been closing and opening the gate at Heritage Hills park.

These neighbors took action after it became apparent that the park was being used for illegal activities at all hours during the day and night. Activities include littering, drinking, fighting, injuries, drugs, shootings, and multiple calls to 911 with emergency vehicles responding to the various situations.

Our efforts have been successful in making the park safer and cleaner.

# **HEAR Real Estate Update**



We moved into the Heritage East Neighborhood in November of 2018 and have really enjoyed the friendly neighbors, amenities, and overall feel of Heritage East. The boundaries of Heritage East are Paseo Del Norte

to the North, Ventura to the West, the Jay Yogeshwar Trail to the South (which separates Heritage East from Tanoan) and Holbrook to the East.

69 New Neighbors purchased homes in Heritage East in 2020. Prices ranged from \$245,000 for a 2 Bedroom/2 Bath Townhome up to \$568,500 for a Detached 5 Bedroom/4 Bath Home. There are currently 5 homes under contract in 2021.

Average days on the market for homes in Heritage East decreased from 42 days in 2019 to 16 days in 2020. Average sales prices in Heritage East increased from \$356,096 in 2019 to \$380,899 in 2020.

The inventory of existing homes is very low, buyer demand is very high and interest rates are still historically low. The factors create a "Sellers Market" in which sellers can sell their homes for top dollar but may have a difficult time finding a home to purchase. With historically low interest rates, lenders are inundated with sellers re-financing their homes.

Market changes in the Greater Albuquerque Area, January of 2021 compared to January of 2020:

- Pending sales for detached homes are up 20.6%
- Average sales prices for detached homes are up 17.4%
- Inventory of existing detached homes for sale is down 60.3%
- Average days on the market is down 44.4%
